For a printed contract, the title of the contract is italicized. The name of the contracting parties should follow the title, and the date the contract was signed appears at the end. If the publisher or organization issued the contract, include that after the date. If it is a lengthy document with several pages, citing specific page numbers can help.



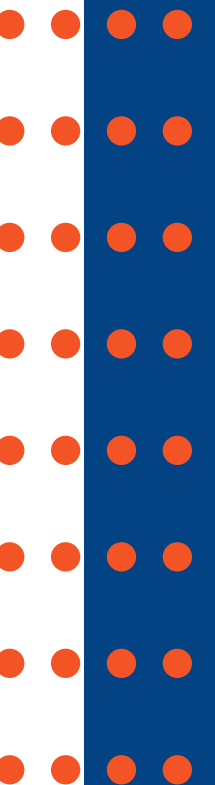


# 2.CITING AN ONLINE CONTRACT

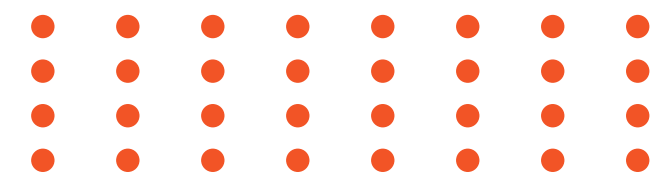
The MLA citation format for a contract varies depending on whether you're citing a printed document or an online contract. Here's the basic structure:

Format:

- Title of the Contract (*italicized*)
- Contracting Parties (if known)





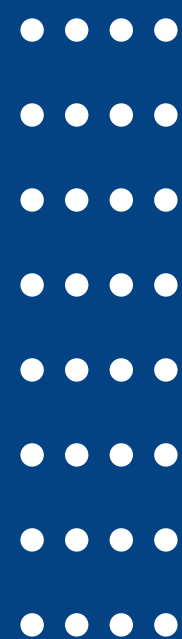


- Date of signing
- Website or Database name
- URL

Example:

- Sales Agreement Between ABC Enterprises and XYZ Ltd. ABC Enterprises, 2021, [www.abc.com/salesagreement](http://www.abc.com/salesagreement). Accessed 5 Apr. 2025.

For online contracts, including the full URL ensures that readers can access the same document. If the contract doesn't have a specific publication date, you can include the access date instead.





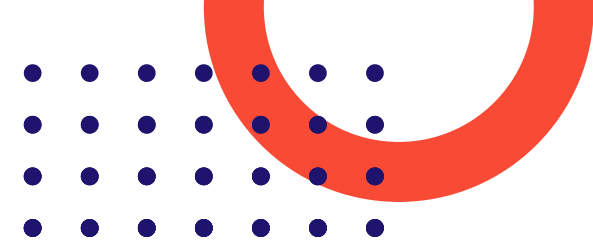
# 3.ADDITIONAL INFORMATION TO CONSIDER

Contract Type: If the contract has a specific type (e.g., "non-disclosure agreement" or "employment contract"), include that detail in your citation.







# In-Text Citations for Contracts

If you are citing a specific page, you may use a page number in the in-text citation as follows:


